Zegona, the LSE Main Market company established to acquire and operate businesses in the European Telecommunications, Media and Technology (“TMT”) sector, announces that KPMG LLP (“KPMG”) has expressed its willingness to act as auditor in place of Deloitte LLP (“Deloitte”), who has resigned as auditor of the group. Deloitte, S.L. will continue in its role as auditor of Telecable, Zegona’s operating business.
